Complete and submit the [online enrollment form\(s\)](#) to enroll your organization and/or its affiliated analysts in the Asbestos Analysts Registry (AAR) program and the Asbestos Analysts Testing (AAT), its associated proficiency program.

All applications will be completed online in the Registry portal. Portal and application access will be granted after enrollment and fee payments have been processed.

The AAR Policy is available on the AIHA Registry Programs [website](#).

All application and annual fees are nonrefundable. Only the unused samples fee may be refunded.

Organization Fees

Annual Registry Program Fee.....\$1,480

- + First year fee due with application. Subsequent years invoiced annually in December.
- + New organizations submitting applications for round 143 or later pay **\$740.00**.

Initial Application and Filing Fee.....\$600

- + Fee due when initially enrolling in the AAR program.

Triennial Application Fee\$600

- + Fee due every 3 years when the triennial application is submitted.

Analyst Fees

An **Analyst Annual Fee** and **Enrollment Fee** will be assessed for every analyst enrollment.

An **Annual Analyst Fee**, **Expedited Enrollment Fee** and **AAT Retest Samples** fee will be assessed for an expedited enrollment.

Analyst Annual Fee (per analyst).....\$240

- + Subsequent years invoiced annually in December.
- + Nontransferable and nonrefundable after the enrollment date for the first AAT round of the 2022.
- + Analysts enrolling for round 143 or later pay the mid-year annual fee, **\$120**.

Enrollment Fee (per analyst)\$220

Expedited Enrollment Fee\$435

- + Analysts enrolling with an initial organization are not eligible for expedited enrollment.
- + *Expedited enrollment can only begin with a retest round.*
- + See AAR Policy Article III, Section 3.12 and Article IV, Section 4.4 for more information on expedited enrollment.

Asbestos Analysts Testing Fees

- + One set of AAT samples is required for every five enrolled analysts.
- + Subsequent years invoiced annually.

•**Analyst additions that do not require additional AAT samples must be submitted by the Final Enrollment Deadline to be included in the round.

- ✦ **Required Fee: Triennial Organization Application fee**

To enroll analyst(s) to my organization.

- ✦ **Required Fees: Analyst Annual Fee and Enrollment Fee, per analyst**
- ✦ **Possible Fee: AAT Samples; one set is required for every 5 analysts enrolled**

To enroll expedited analyst(s) to my organization and expedite the application process and AAT proficiency determination.
Expedited enrollments can only start with an AAT retest round.

- ✦ **Required Fees: Analyst Annual Fee, Expedited Enrollment Fee for each analyst and AAT Retest Sample fee**
