## COVID-19 Resources from AIHA



Thanks to our robust and prolific volunteer community, AIHA has been able to assemble a library of science-based, peer-reviewed guidelines on various technical topics related to the control and mitigation of SARS-CoV-2. These include the application of engineering controls such as ventilation, enhanced filtration, and physical barriers; the use of germicidal ultraviolet radiation; enhanced cleaning and disinfection practices; and so many more topics relevant to issues that the public and the OEHS community face while mitigating the spread of COVID-19. - Guidance Documents for OEHS Professionals:** AIHA Volunteer Committees published guidelines including *Effective and Safe Practices*, *Guidance for Custodians, Cleaning, and Maintenance Staff*; *Employers Guide to COVID-19 Cleaning and Disinfection in Non-Healthcare Workplaces*; *Focus on Construction Health: COVID-19*; *Recovering from COVID-19 Building Closures*; *Reducing the Risk of COVID-19 Using Engineering Controls*, with supplement document; *Use of Real Time Detection Systems to Protect the Public During COVID-19*; and *Workplace Cleaning for COVID-19*. Most of AIHA guidance documents are also available in Spanish.
- Infographics:** Including one on the safe use of UVC radiation, one on proper respirator use for healthcare workers and first responders, and one on the ergonomics of working from home. Most of these are also available in Spanish.
- White papers:** Including one on PPE for COVID-19—also available in Spanish—another on germicidal ultraviolet radiation and another on workers' rights.
- Books:** *The Role of the Industrial Hygienist in a Pandemic* publication was made free to all AIHA members; one of the checklists in the book was downloadable for free on our website.
- Webinars:** Archived recordings such as a joint AIHA and Association for Professionals in Infection Control and Epidemiology (APIC) webinar on ventilation, surface disinfection, and PPE.



## Back To Work Safely Initiative™



In May 2020, AIHA launched the **Back to Work Safely™** (BTWS) initiative ([bit.ly/btws-home](https://bit.ly/btws-home)), which would come to embody the efforts of a task force consisting of just under 30 members. Starting with ten initial guidance documents for the industries hardest hit by COVID-19, the task force created 27 total guidelines, each specific to a particular work environment, by January of 2021.

These guidance documents feature specialized expert-written guidelines that help businesses to safely reopen, resume operations, and re-engage with the public as they emerged from quarantine restrictions.

As staff disseminated the guidance documents to the national media, Alan Fleeger, the leader of the BTWS volunteer task force and a former AIHA president, reached out to social influencer, entrepreneur, and businessman Mark Cuban to inform him about these vitally important documents. Mr. Cuban endorsed our volunteers' efforts, introduced the documents to his audience of over a million social media followers, and spoke of them in interviews. Within six months, the Back to Work Safely guidelines had been downloaded over one million times.

In support of the BTWS initiative, some AIHA volunteers began translating the guidance documents into Spanish while others undertook the colossal task of harmonizing the language of the documents.

Although the task force was dissolved at the end of 2020, a "tiger team" made up of former task force volunteers continues to revise and modify the Back to Work Safely documents based on emerging research and new directives from federal agencies and public health officials.





Since March 2020, AIHA has maintained a publicly-accessible **COVID-19 Resource Center** webpage ([bit.ly/COVID-19AIHA](https://bit.ly/COVID-19AIHA)) that provides employers and workers with up-to-date information and research findings on COVID-19 from various Occupational and Environmental Health and Safety organizations and public health agencies. As information on COVID-19 risks, safety practices, and other concerns accumulated from various community and work environments, AIHA's subject matter expert volunteers remained unbiased sources of information for the public, other AIHA members, and allied organizations.

### AIHA Partnerships and Alliances

- AIHA joined the National Safety Council's SAFER Task Force.
- AIHA joined ACOEM and AHA efforts for in-kind donations of surplus PPE to healthcare workers.
- AIHA and ABSA International issued a joint statement about resource sharing and collaboration between the two organizations during the pandemic.
- AIHA helped OEHS professionals receive recognition as essential workers by the federal government.

### AIHA Members in the Media

- The "5 on the Frontline" podcast series hosted by Mark Ames, AIHA's Director of Government Relations, has featured several AIHA expert members who discussed key points of various industries' recoveries from COVID-19.
- Several AIHA members and leaders assisted *Wall Street Journal* reporters for the newspaper's special in-depth story on potential changes and guidelines for the future workplace, titled "The New Normal of Everyday Life."
- Several AIHce EXP presenters shared their stories of participation in pandemic response efforts for a video highlighting IH/OEHS professionals during the crisis.
- AIHA members shared their expertise on pandemic-related issues in the workplace as guest speakers and interviewees for a variety of webinars, podcasts, and articles by outlets including *Business Insider*, *USA Today*, *Bloomberg Law*, *NPR*, *Wall Street Journal*, *Washington Post*, *ABC News*, and *Good Morning America*.
- AIHA members, through the online newsletter *EHS Daily Advisor*, provided expertise and clarification about properly selecting, fitting, and decontaminating PPE; monitoring and treating indoor air; and surface disinfection.
- AIHA members made donations to local healthcare facilities.
